Through this work, the council is not only identifying the issues relevant to small business across Queensland but is actively working to progress solutions and opportunities that will improve the small business operating environment.</p>
Achievements	<p>In 2018-19, the Council undertook the Entrepreneurial Pipeline project to investigate opportunities for the Queensland Government to support the entrepreneurial pipeline of Queensland artisan food and beverage producers.</p> <p>Key achievements from this project include:</p> <ul style="list-style-type: none"> • the Queensland Small Business Week 2019 'Taste and Trade' event held 31 May 2019 at Boggo Road Gaol which connected buyers, stockists and distributors with more than 35 local producers • release of a searchable online Queensland Government Food and Beverage Supplier Directory for government buyers. The directory helps easily locate Queensland produce for events and corporate functions • assisting Logan City Council to introduce a 'brewery friendly' planning guideline • opening of three new regional Queensland Government Manufacturing Hubs in Cairns, Townsville and Rockhampton. The hubs support local manufacturers, with a focus on food manufacturing, food transformation and product innovation • \$885 million of targeted payroll tax initiatives to support small-to-medium sized businesses • reported on small business activities and issues in regional Queensland, including hosting a regional meeting in Cairns • participated in a joint meeting with members of the National Small Business Commissioners network in 2018 • the Council's subcommittee, the Better Regulation Taskforce conducted a regulatory review of the impact and influence of digital disruption on small business, which generated the development of the Queensland Government Response and Action Plan.
