Implications for school based apprentices and trainees (SATs)
Information for Pre-qualified Suppliers



THE USER CHOICE 2010-2015 PROGRAM

The User Choice Program provides public funding for the delivery of accredited, entry level training to apprentices and trainees, **including school based apprentices and trainees**.

Under the User Choice 2010 -2015 program, funding specifically targets the occupational outcomes of the apprenticeship or traineeship.

SCHOOL BASED APPRENTICESHIPS AND TRAINEESHIPS (SATS)

School based apprentices and trainees undertake an apprenticeship or traineeship as part of their high school studies. A school based apprentice and trainees' employment and/or training arrangements must impact on their school timetable for the program to be considered 'school based'. Apprenticeships or traineeships which do not have an impact on the student's school timetable are not a SAT.

SATs aim to provide students with a clear pathway from school, to employment after school. The objective of a SAT is to support the post school career goals of a student. Different vocational education and training options are more suitable to serve other objectives.

The <u>funding priority</u> of a qualification usually determines the level of public funds contributed to training regardless of whether the qualification is an apprenticeship or traineeship.

From 1 July 2013, the User Choice Policy was changed to remove the 100% Government contribution to SATs and align future funding to the priority level of the qualification.

- Priority One (100 percent subsidised) lead to occupations deemed to be critical priorities in the Queensland.
- Priority Two (75 percent subsidised) lead to occupations not deemed critical in Queensland but considered as high priorities.
- Priority Three (50 percent subsidised) lead to occupations not deemed critical in Queensland but considered as medium priorities.

This change of funding will provide an opportunity for successful SATs to enter a training pathway that will provide greater opportunities for employment and sustainable job outcomes.

Existing students will not be disadvantaged and existing subsidy levels will be honoured.

THE USER CHOICE 2010-2015 POLICY

Apprentices and trainees can only receive one government contribution for a User Choice funded qualification at any single point in time.

In addition, a maximum of two government contributions will be funded per participant under this program.

Qualifications which do not contribute to the maximum government contribution are:

- Qualifications funded outside the User Choice 2010–2015 program
- User choice funded qualifications which commenced, but were not completed

A second qualification is funded **only** if it is:

- A Priority One qualification, or
- A higher priority than the first qualification.

IMPLICATIONS FOR SCHOOL BASED APPRENTICESHIPS AND TRAINEESHIPS

SATs support student vocational learning and employment pathways. A key purpose is to provide a clear pathway from school to employment after school. However, some SATs, while providing valuable workplace exposure and the development of a student's vocational skills and knowledge, do not provide as a direct pathway into employment as others.

For example, many students who participate in some lower priority SATs such as retail, sport and recreation and business, do not transition directly into employment after school and often wish to access funding for a second apprenticeship or traineeship.

Under the User Choice arrangements, students, schools, parents and employers need to carefully consider any potential impacts a SAT may have on s student's future entitlement to another funded apprenticeship or traineeship.

A maximum of two funding contributions will be provided by the Government, AACs must discuss the Multiple Government Contribution section of the User Choice Policy to assist students and their parents in making informed decisions.

Before accepting to be a student's Supervising Registered Training Organisation, training providers will need to know whether or not a student will be funded. AACs need to ensure that prior to signing up an apprentice or trainee they ascertain whether a student will be eligible for funding.

SCENARIOS HIGHLIGHTING HOW THE USER CHOICE 2010- 2015 PROGRAM OPERATES

Scenario 1

A student commences and completes a Certificate II in Hospitality (Priority Three qualification) as a school-based trainee. Prior to signing up in this qualification, the student needs to understand the Multiple Governments Contributions section of the User Choice policy and its implications on the student obtaining funding for additional qualifications.

The student completes the qualification but does not transition into the hospitality industry and later decides to undertake a Certificate II in Hairdressing (Priority Three qualification).

Will the student be funded for their second qualification?

No. The second qualification is not a higher priority. This student will be funded for a second qualification if they select a qualification that is either a Priority One or Priority Two qualification.

Scenario 2

A student wants to undertake a school based traineeship, Certificate II in Sport and Recreation (Priority Three qualification). Prior to signing up in this qualification, the student needs to understand the Multiple Governments Contributions section of the User Choice policy and its implications on the student obtaining funding for additional qualifications.

The student signs up into the traineeship and completes it, but does not transition into the sport and recreation industry and later decides to undertake a Certificate III in Community Services Work (Priority Two qualification).

Will the student be funded for their second qualification?

Yes. The student will be funded for the second qualification as it is a higher priority than the first qualification. The student will not be eligible for any more funding under the User Choice 2010-2015 program, so it is important that the second qualification provides a transition to the workforce after school.
