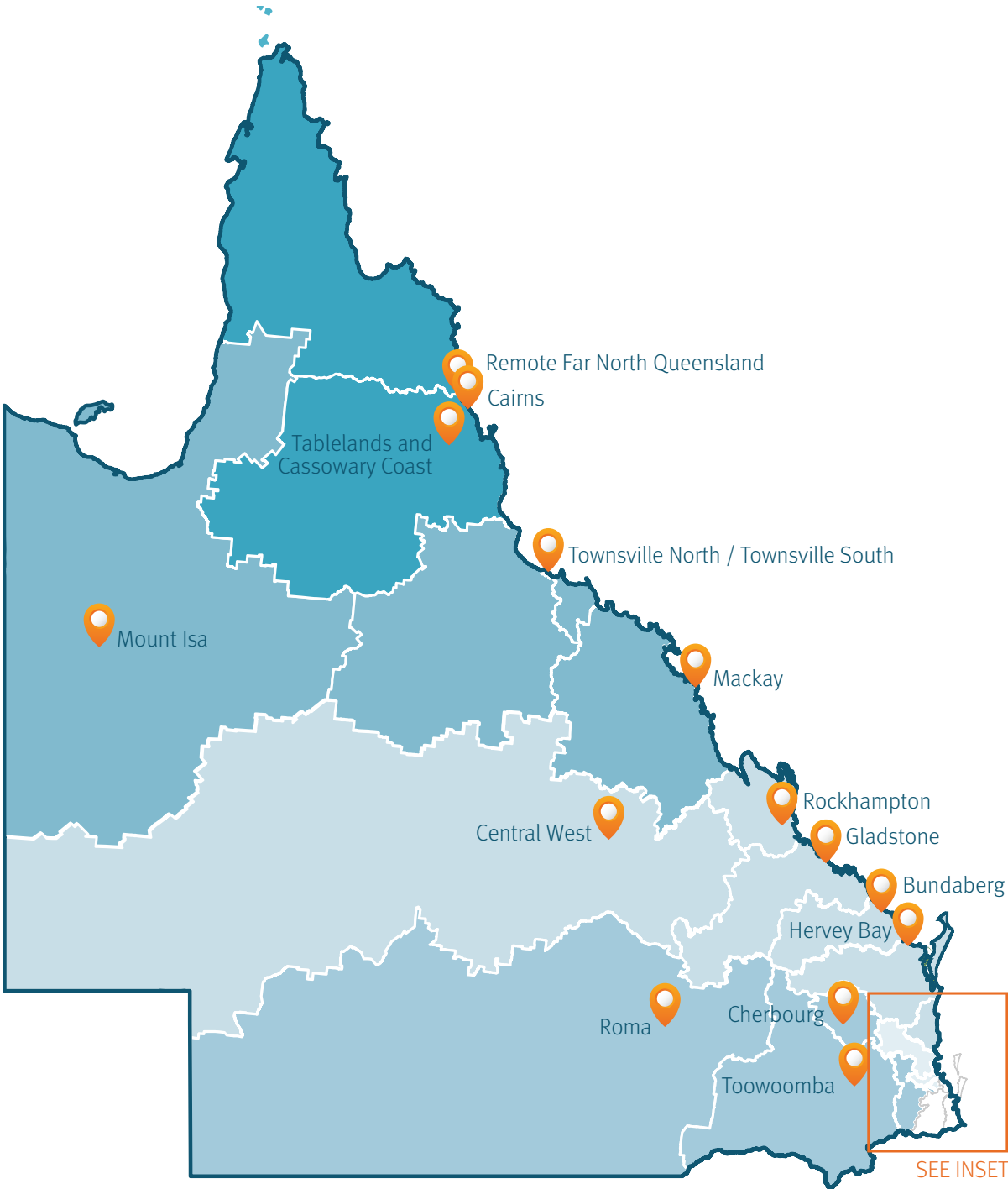
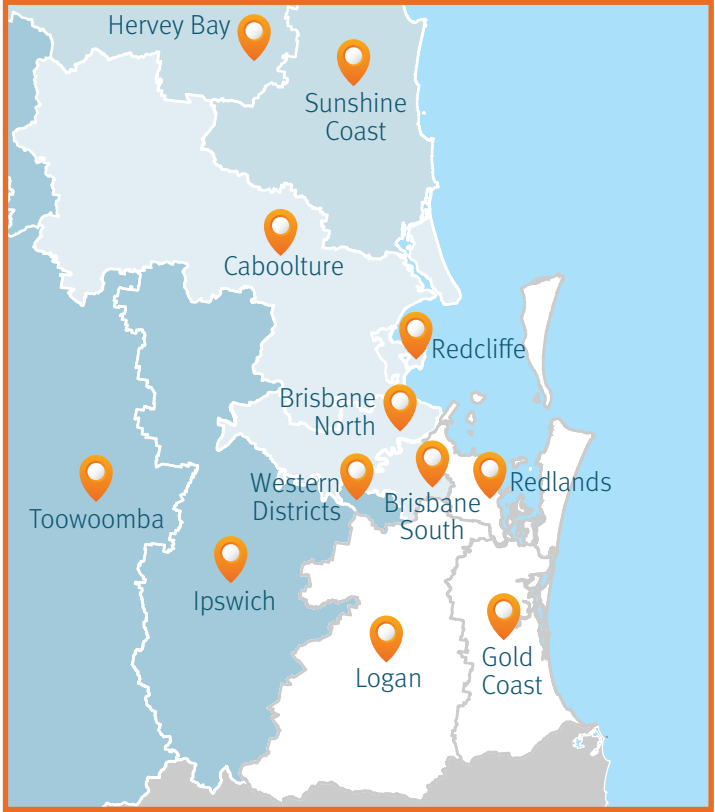


Youth Justice Services in Queensland

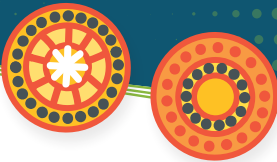

* **Youth Justice Case Management** is work with young people who are subject to youth justice orders. It aims for a holistic approach to service delivery providing programs and interventions to address young people's needs across a range of domains including the issues that underpin offending behaviour.

** **Youth Justice Offender Support Services** are also delivered at Palm Island, Mornington Island and Doomadgee.

*** **Electronic Monitoring Trial (joint initiative with QPS)** This is being trialled in Townsville, Logan, Moreton (Caboolture and Redcliffe), Brisbane North and the Gold Coast. It is also being expanded to Cairns, Toowoomba and Mount Isa, and eligibility widened to young people aged over 15 years.
